H & S Inspector Recruitment

The Ontario government is set to employ the largest number of Labour Inspectors in Provincial history.

The new inspectors will play a key role in protecting workers by checking and enforcing that workplaces are following OH&S legislation. They will be enforcing the following:

- Inspecting workplaces to ensure COVID–19 protections are in place;
- Investigating potentially hazardous situations, critical injuries, fatalities and work refusals:
- Compliance with the legislation
- Stopping unsafe work from being performed and:
- Making recommendations to initiate prosecutions

#### **National Workplace** Violence & Harassment Survey

The survey was launched October 21st and is being conducted by the Canadian Labour Congress, along with researchers from Western University and U of T.

The purpose is to help assess the "prevalence of workplace violence and harassment", as well as reviewing any effect the COVID-19 pandemic may have had.

For employers under federal jurisdiction regulations will come into force on January 1st, 2021.

# **Worker Health and Safety** Awareness in 4 Steps | Online

It focuses on the health and safety rights and responsibilities of workers, supervisors, and employers. It also serves as a general introduction to workplace health and safety.

# Seasonal Health & Safety Advisories

- Slips, trips, falls Icy conditions, snow covered hazards
- Carbon monoxide Colourless odorless gas produced by fuel powered equipment
- Cold stress Exposure to the cold can lead to frostbite and hypothermia.
- Hypothermia Occurs when the body can no longer maintain its core temperature, causing persistent shivering, confusion, and poor coordination.
- Frostbite Parts of the body are exposed to extremely cold temperatures or come into contact with cold objects, causing the tissues to freeze.

#### Joint Health & Safety Training

In Ontario, most workplaces with 20 or more workers must have a joint health and safety committee (JHSC). made up of at least one worker member and one management member.

The committee's primary role is to identify workplace health and safety issues and bring them to the attention of the employer.

Under the OHSA, at least one worker member and one management member on a JHSC must be certified.

As an employer, you must keep proof of your workers JHSC certification and make it available to a Ministry of Labour, Training and Skills Development inspector, on request.
