CIHSA.ca H & S Advisory - Fatigue from Mask Use

While the reduction in the transmission of COVID-19 is paramount, the effects of mask use needs to be considered. Some of the main findings on the effects on the body are:

- Increase in discomfort
- Increased heart rate
- Increase in body temperature

With the prolonged use of masks and respiratory hazards, it is important to implement frequent rest breaks in a cooler environment and increasing water intake.

Amendments to Respirator **Regulations in** 2020

As you know Regulation 833 came into affect in January this year.

As a reminder, it's the Control of Exposure to Biological or Chemical Agents. In other words its about air quality and contaminants in the workplace.

The changes to Reg. 833 came by way of another regulation called O.REG/185/19.

There are approximately 15 new terms and Section 6 of the regulation was replaced.

Now there is a specific requirement for written procedures regarding how the employers intends to test and monitor contaminants.

Further to that, if your organization provides Respirators your safety program must include procedures regarding care and use, proper selection of equipment based on need, and fit testing.



COVID-19 Regulation Updates:

Most recently the regulation requires compliance with the Public Health Screening Tool for Workplaces for workers or essential visitors entering the work environment. The following is a snapshot of the screening tool.

Required Screening Questions: 1. Do you have any of the following new or worsening symptoms or signs? Symptoms should not be chronic or related to other or known causes or conditions.

Fever or chills Difficulty breathing or Cough Sore throat, trouble sv Runny nose/stuffy nos Decrease or loss of sr Nausea, vomiting diar Not feeling well, extreme

2. Have you travelled 3. Have you had close case of COVID-19?

office or worksite. If the individual answers YES to any questions 1 through 3, they have not passed and should not enter the workplace (including any outdoor, or partially outdoor, workplaces). They should go home to self-isolate immediately and contact their health care provider or Telehealth Ontario (1-866-797-000) to find out if they need a COVID-19 test.

COVID-19 Regulation Updates

Federal Government Expands Employer Duties to Address Violence & Harassment

Legislation aimed at preventing work violence and harassment and expanding protection to more federally-regulated workers will come into force on January 1, 2021.

All applicable recommendations made by the Ministry of Heath are per Ontario Regulation 364/20 which requires us to follow the recommendations of Public Health Officials and the Chief Medical Officer. https://www.ontario.ca/laws/regulation/200364

Best practices

A best practices document was developed for all to understand the measures required for classroom training during COVID-19 where remote or virtual training cannot be accommodated.

Considerations

The elements considered were class sizes and planning, staggering breaks, procedures for avoiding crowding in washrooms and elevators; screening, hygiene and sanitation access along with the general distancing, PPE right down to discouragement of sharing supplies. All practices we tend to take for granted and are easily forgotten.


