# WORKING AT HEIGHTS TRAINING REQUIREMENTS

Working at Heights training is a requirement set out in O. Reg. 297/13 *(OHSA)* and must be completed by the **April 1, 2017** deadline.

Employers will be required by O. Reg. 297/13 (OHSA) to make a training record available to an inspector on request. This may include an employer's own method of record keeping or copies of each worker's CPO issued proof of completion.

Inspectors will take enforcement action, as necessary, in response to any violations of the OHSA and its regulations, taking into account the particular circumstances they encounter on the project.

Enforcement may include issuing orders requiring the employer to comply. An order could require compliance within a certain timeperiod. If the hazard was imminent, a stop work order could be issued.

A non-compliant employer could also be prosecuted, where appropriate, under the Provincial Offences Act. MCAT encourages all its members to ensure that their workers are properly trained.



Don't delay! Get your employees trained well before the deadline. It will be too expensive to endure long line ups and delays to your projects by waiting to comply.

# **BILL S-224: CANADA PROMPT PAYMENT ACT**

Prompt Payment Legislation, Bill S-224, introduced into the Senate on April 13, 2016, has passed 1st & 2nd reading in the Senate and is now before the Senate Committee on Banking, Trade and Commerce.

Hearings were held on February 2nd, 8th & 9th, 2017 featuring MCA Canada, Senator Plett and numerous industry stakeholders and representatives of the federal government.

We support the need to eliminate payment delays for completed work. MCAC is diligently working with all levels of government to initiate protocols to ensure contractors get paid for the work they have successfully completed.

We expecting additional are testimony from constitutional experts. After which, the Senate committee will be meeting and going through the Bill "line by line" together with proposed amendments.

It is our understanding that once this process is finalized, the Bill and amendments will be brought

forward for third reading in the Senate and hopefully passed. Then off to the House of Commons for "Round 2".

We will keep you updated on this very important legislation.

### **CAUTION TO ESTIMATORS!**

When pricing work in the areas covered by the MCAO Collective Agreement, Zone 10 (Barrie), please note the last sentence on Page 158, Schedules Rates of Pay, Section "A" that states: "There shall be only one (1) rate of wages paid on every job for each category." This could be a costly oversight when pricing work in the Barrie area.

#### MEDICAL MARIJUANA IN THE WORKPLACE

On February 8, 2017, Mr. Paul Macchione Associate with Norton Rose Fulbright LLP, delivered an informative presentation entitled "Marijuana Coming to a Workplace Near You".

According to Health Canada, in 2014 there were 40,000 active medical marijuana prescriptions. The number is projected to increase to 500,000 by 2024. In line with this expected increase, employers must be prepared to deal with related issues in the workplace particularly where employees are in safety sensitive or safety critical roles.

Mr. Macchione covered important related topics such as: Workplace Safety, Drug Testing, Human Rights Obligations, Best Practice. Employers are encouraged to be proactive in implementing relevant changes to their current Policies & Procedures.
