Benefits of Hiring an Apprentice

What if one simple hiring practise could offer numerous tax credits and bonuses, help you build a loyal team and allow you to contribute to your industry's future, among many other perks; would you be interested?

Currently, in Ontario only 20% of eligible employers train apprentices, though the benefits (to both parties) are countless.

If you are a skilled trades employer, here are the TOP FIVE reasons you should consider hiring an apprentice:

1. Financial: By hiring an apprentice, employers become eligible for numerous different tax credits, grants and bonuses. For instance, the Ontario government provides the Apprenticeship Training Tax Credit to qualifying businesses that hire apprentices in certain skilled trades; an Employer Signing Bonus to sponsors who register new apprentices in sectors in which skilled workers are in high demand; and an Employer Completion Bonus to sponsors whose apprentices complete their programs.

2. Loyal employees: Apprenticeship programs help create some of the most loyal employees. A 2010 Canadian Apprenticeship forum report shows that apprentices felt more loyalty to employers who supported and eventually hired them. (Source: "The challenge of finding an employer-sponsor").

3. Prepare for the future: To create or maintain a successful business, it is important to consider your future needs. The average age of a tradesperson today is 55 years old, which means some of those workers are nearing retirement. Hiring and training an apprentice now will have you prepared for when that time comes.

4. Your business, your training: By training an apprentice to the College's training standards and best practises, you can mould them to ensure they are a good fit for your company's needs and culture. This means they are not only learning the necessary skills of the trades, but also those specialized skills that are unique to your particular business.

5. Hire the best: Local colleges, high schools and training programs can help you track down the best talent and match you with the most qualified apprentice candidate.

Apprenticeship Job Creation Tax Credit (AJCTC)

Allows qualifying employers to claim up to \$2,000 per year for each eligible <u>apprentice</u>. Link: <u>http://www.cra-arc.gc.ca/E/pbg/tf/t2038 ind/t2038-ind-fill-14e.pdf</u>

Apprenticeship Training Tax Credit

Allows qualifying employers to claim up to \$5,000 per year for each eligible apprentice. The maximum credit over the first 36-month period of the apprenticeship is <u>\$15,000</u>. Link: <u>http://www.fin.gov.on.ca/en/credit/attc/</u>

Employer Signing Bonus

A \$2,000 bonus available to employers who register new apprentices in sectors where there is a high demand for skilled trade <u>workers</u>. Link: <u>http://www.tcu.gov.on.ca/eng/employers/emp_bonus.html</u>

Apprenticeship Completion Employer Bonus

Employers can earn a \$1,000 taxable grant for each apprentice they employ and train who successfully completes his or her <u>apprenticeship</u>. Link: <u>http://www.tcu.gov.on.ca/eng/employmentontario/employers/appr_completion.html</u>

The <u>HirewithConfidence.ca</u> website offers free postings of job openings, with the ability to review journeyperson or apprentice candidates, for any of the College's employer class members. There is an annual cost of \$120 + HST for an employer-class membership, but that fee is waived if the owner of the company is already holding another membership in the College.

Prompt Payment - Bill S-224: The Legislative Process

The following are the stages that a bill must pass through before becoming law:

- Notice of motion for leave to introduce and placement on the House of Commons Order Paper;
- Preparation of a bill by a committee (where applicable);
- Introduction and first reading;
- Reference to a committee before second reading (where applicable);
- Second reading and reference to a committee;
- Consideration in committee;
- Report stage;
- Third reading (and passage);



- Passage of Senate amendments by the Commons (where applicable);
- Devel Accent: and
- Royal Assent; and
- Coming into force.

A bill that is introduced in the Senate must pass through essentially the same stages, except that it is considered first in the Senate and subsequently in the House of Commons. Most bills may be introduced in either House, except for bills which involve spending or relate to taxation, which must be introduced in the House of Commons.

We are at this stage in the legislative process towards passing of Bill S-224

Bill 70, Schedule 17, New Policy & Information Session

On December 8, the Ontario Legislature passed amendments to the Ontario College of Trades and Apprenticeship Act, 2009 (OCTAA) – Bill 70, Schedule 17. As required by these legislative changes, in June 2017, the Ontario College of Trades released a new comprehensive Compliance and Enforcement Policy available at the following link: http://www.collegeoftrades.ca/latest-news/compliance-and-enforcement-policy.

On June 20, 2017, 9am to 10am, MCAT will be hosting an information session with guest speaker, Jennifer Cooper, Director, Legal & Regulatory Affairs. We encourage MCAT Members to attend as useful information will be presented regarding the implementation of these amendments and how skilled trade workers & contractors will be impacted.

Working at Heights Training Deadline Extension

On March 29, 2017, the Ministry of Labour informed that the April 1, 2017 Working at Heights training deadline has been extended to October 1, 2017. This training deadline extension is not intended to allow contractors to postpone or ignore the legislated Working at Heights training requirements. This training deadline extension is only available for workers who have already completed the Fall Protection training before April 1, 2015 and who can show proof of enrolment in a Working at Heights training program with completion prior to October 1, 2017. The employee or employer must be able to provide proof of enrolment to be provided to an inspector upon request.
